17 DEPARTMENT, is hereby ratified, and affirmed and approved in all respects,
18 respectfully for:

19 All labor, insurance, material, equipment, tools, power,
20 transportation, miscellaneous equipment, etc., necessary for
21 improvements to the concrete deck gutter areas of the
22 Botanical Conservatory glass roofs. Improvements will
23 include removal of existing concrete decking and
24 replacement with new concrete gutters;

25 involving a total cost of FOUR HUNDRED SIXTY-FIVE THOUSAND FOUR
26 HUNDRED SEVENTY-SEVEN AND 00/100 DOLLARS - (\$465,477.00). A
27 copy of said Contract is on file with the Office of the City Clerk and made
28 available for public inspection, according to law.



The Fort Wayne Parks and Recreation Department is requesting approval on behalf of the Board of Park Commissioners for a contract with Hamilton Hunter Builders Inc. for the Botanical Conservatory Gutter Improvements Project. The project consists of improvements to the concrete deck gutter areas of the Botanical Conservatory glass roofs. Improvements will include removal of existing concrete decking and replacement with new concrete gutters. The project was bid with one base bid and 6 alternate bids. After review of all of the bids the parks department would like to accept the base bid, along with alternate bids 1,2,4, and 6. Given this combination of base bid and alternate bids, the low bidder is Hamilton Hunter Builders at \$465,477.00.

Funding Source: \$250,000.00 from Park Bond, \$215,477.00 from Parks Capital Improvement Funds.
