SPECIAL ORDINANCE NO. S-37-17

AN ORDINANCE approving CONSTRUCTION CONTRACT - LAKE AVENUE SIDEWALK CONSTRUCTION - RESOLUTION #0191N (\$184,937.61) between MALOTT CONTRACTING and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the CONSTRUCTION CONTRACT - LAKE AVENUE SIDEWALK CONSTRUCTION - RESOLUTION #0191N by and between MALOTT CONTRACTING and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for the project: sidewalk will be constructed on the south side of Lake Avenue from Beacon Street to Annette Avenue. The scope of work will also include curbface walk, ADA curb ramps, rest nodes, curbs and pavement markings;

involving a total cost of ONE HUNDRED EIGHTY-FOUR THOUSAND NINE HUNDRED THIRY-SEVEN AND 61/100 DOLLARS - (\$184,937.61). A copy of said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.


