

AN ORDINANCE approving the awarding of ITB #4167 BID PACKAGE 4 AND 5, RIVERFRONT DEVELOPMENT PHASE 1 - (\$2,029,780.00) by the City of Fort Wayne, Indiana, by and through its Department of Purchasing and HAMILTON HUNTER BUILDERS for the PARKS AND RECREATION DEPARTMENT.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA;

SECTION 1. That ITB #4167 BID PACKAGE 4 AND 5, RIVERFRONT DEVELOPMENT PHASE 1 - between the City of Fort Wayne, by and through its Department of Purchasing and HAMILTON HUNTER BUILDERS for the PARKS AND RECREATION DEPARTMENT, respectfully for:

Bid Package 4 and 5 for Phase 1 of the Riverfront Park at the corner of Harrison and Superior Streets - Bid Package 4 includes all work associated with the site concrete throughout the park. Bid Package 5 includes all work associated with any masonry installation;

involving a total cost of TWO MILLION TWENTY-NINE THOUSAND SEVEN HUNDRED EIGHTY AND 00/100 DOLLARS - (\$2,029,780.00) all as more particularly set forth in said ITB #4167 BID PACKAGE 4 AND 5, RIVERFRONT DEVELOPMENT PHASE 1 which is on file in the Office of the Department of Purchasing, and is by reference incorporated herein, made a part hereof, and is hereby in all things ratified, confirmed and approved.



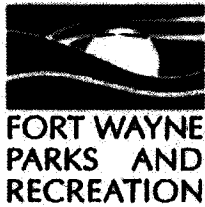

The Fort Wayne Parks and Recreation Department is requesting approval on behalf of the Board of Park Commissioners for a contract with Hamilton Hunter Builders for Bid Package 4 & 5 for the Phase 1 Development of the Riverfront Park. The overall project consists of creation of a park located at Harrison and Superior Streets.

Bid Package #4 for Site Concrete was bid by two firms. After consideration, Base Bid 4 was accepted. The low bid is from Hamilton Hunter Builders at \$1,780,629.00. Bid Package #5 for Masonry Construction was bid by three firms. After consideration, Base Bid 5 and Alternate 15 Trailhead Restroom were accepted. The low combined bid is from Hamilton Hunter Builders at \$249,151.00. The combined bids for packages 4 & 5 total \$2,029,780.00.
