NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA;

SECTION 1. That ITB #4167 - BID PACKAGE 13 AND ALTERNATE 15- RIVERFRONT DEVELOPMENT PHASE I - between the City of Fort Wayne, by and through its Department of Purchasing and PROJECT DESIGN AND PIPING for the PARKS AND RECREATION DEPARTMENT, respectfully for:

Bid Package 13 for Phase I of the Riverfront Park at the corner of Harrison and Superior Streets - Bid Package 13 includes all work associated with mechanical systems which includes plumbing and HVAC systems in the pavilion;

involving a total cost of EIGHT HUNDRED NINETY THOUSAND FOUR HUNDRED AND 00/100 DOLLARS - (\$890,400.00) all as more particularly set forth in said ITB #4167 - BID PACKAGE 13 AND ALTERNATE 15 - RIVERFRONT DEVELOPMENT PHASE I - which is on file in the Office of the Department of Purchasing, and is by reference incorporated herein, made a part hereof, and is hereby in all things ratified, confirmed and approved.
