SPECIAL ORDINANCE NO. S-104-17

AN ORDINANCE approving CONTRACTUAL SERVICE AGREEMENT - REPAIR AND RESTORATION OF SIDEWALKS - \$220,000.00 between the FORT WAYNE URBAN LEAGUE and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the CONTRACTUAL SERVICE AGREEMENT - REPAIR AND RESTORATION OF SIDEWALKS by and between the FORT WAYNE URBAN LEAGUE and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for repair and restoration of sidewalks with trip hazards in various neighborhoods within the City of Fort Wayne;

involving a total cost of TWO HUNDRED TWENTY THOUSAND AND 00/100 DOLLARS - (\$220,000.00). A copy of said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.






**Amendment No. 2 to

Contractual Agreement with
The City of Fort Wayne Street Department
2017**

Fort Wayne Urban League proposes the following items for the repair and restoration work that the City Street Department is requesting. With the partnership of employment of Fort Wayne Urban League, Fort Wayne Urban League employees will begin restoration work as soon as the ground thaws, and will continue working until or through December 2017. A crew will begin the work under general supervision of Jonathan C. Ray and as the general jobsite supervisor Maurice Smith. There will be a group of 4 Fort Wayne Urban League employees hired. All employees will be subject to the general hiring guidelines and employment regulations of Fort Wayne Urban League. The restoration staff will be held to all safety guidelines specified by The City Fort Wayne Street Department. The general hourly pay rate for the crew of 4 employees and one supervisor is \$180.00. The pay scale is subject to change, due to weekly crew changes and personnel daily schedules, but will not exceed 180.00 per working hour.

Any equipment and/or tools used by Urban League employees will be provided by the general jobsite supervisor. Replacement of those equipment and/or tools will be the responsibility of the general jobsite supervisor. All materials necessary for job completion will be charged to City Street Department over and beyond the general hourly rate. Any materials over the cost of \$300 will need prior approval by the Street Department for reimbursement. The items included as part of material fees would include concrete, rebar, expansion, curing, form release, gasoline, hand tools, concrete forms and minor equipment repairs. All receipts and invoices will be returned to City Street Department for their records.

The City of Fort Wayne's Public Works Division has established a partnership with The Urban League to repair sidewalks while providing skill building and on-the-job training for members of our community.

Working under the supervision of the Street Department, the Urban League has trained a crew to repair sidewalks with trip hazards in various neighborhoods throughout the community. This arrangement began in April and has allowed us to accomplish more sidewalk repair, at a more cost-effective rate. The demand for skilled labor, and the large number of construction projects is driving up the prices, and the demand for contractors. This program frees up our contractors for other projects while building a new force of skilled workers to do the job.

To continue this work into the fall months we will be requesting an additional \$130,000 for a total of \$220,000.
