AN ORDINANCE approving CONSTRUCTION CONTRACT - GREENWAY - HANNA STREET TRAIL - RESOLUTION #0072R - \$213,212.00 between WAYNE ASPHALT and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the CONSTRUCTION CONTRACT - GREENWAY - HANNA STREET TRAIL - RESOLUTION #0072R - by and between WAYNE ASPHALT and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for construction of a 10 foot wide, 0.51 mile long asphalt trail on the west side of Hanna Street from Burns Boulevard to 370 feet north of US 27. The project also includes pedestrian crossings, ADA ramps, updating the drainage flow in ditches, and a park bench;

involving a total cost of TWO HUNDRED THIRTEEN THOUSAND TWO HUNDRED TWELVE AND 00/100 DOLLARS - (\$213,212.00). A copy of said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.


