purchase and planting of 1454 trees in the City right-of-way and City parks and replacing a few damaged and diseased trees;



Total purchases/planting services for trees for 2017 have surpassed \$100,000, thus requiring Council approval. A total of \$284,665.00 in tree purchases and planting services are being requested in this approval. With the approval of this contract we will be able to plant 1454 trees on our streets and in our parks. Trees offer significant financial benefits through reduced energy cost and increased property values. Some of the environmental benefits include decreased energy consumption, storm water management, and decreased ground and air pollutants. Trees tie neighborhoods to community and increase connections between neighbors. If we discontinue the planting of trees in our city, the overall aesthetic beauty and quality of our city will diminish.</u></p>

The total purchase of trees through the City's contracted supplier (under a publicly bid price agreement) will exceed \$100,000 for 2017, requiring Council's approval.





