**SECTION 1.** That the purchase of a Unity 450F disk enclosure with 75 terabytes of data storage and maintenance for these systems from Data Strategy for a total cost to the City of \$157,050 is hereby approved in all respects.


**SECTION 2.** That the City is authorized and directed to take all action necessary for the purchase of this system by and through Data Strategy.

**Subject: Purchase of Unity 450F disk enclosure with 75 terabytes of data storage**

**Members of City Council:**

This ordinance is to authorize the purchase of Unity 450F disk enclosure with 75 terabytes of data storage from Data Strategy.

The purchase of this disk enclosure helps the city in two ways. The additional storage helps meet the demand of departments for more disk space.

It also helps the city in a less obvious way by allowing us to process data faster. First, the new data storage is intrinsically faster than the previous equipment. Second, the new disk enclosure allows the installation of faster virtual servers.

We expect to see faster response times in our GIS systems and permit processing systems as a direct result of this purchase.

This upgrade is a joint project between Allen County (on a separate contract), Fort Wayne Civil City, and City Utilities.
