17 from Tyler Technologies, Inc. for a total cost of \$17,550 is hereby approved in
18 all aspects.

19 **SECTION 3.** That the City is authorized and directed to take all action
20 necessary for the purchase of this system by and through Tyler Technologies,
21 Inc.

22 **SECTION 4.** That this Ordinance shall be in full force and effect from
23 and after its passage and any and all necessary approval by the Mayor.
