In regards to the Diesel Fuel for 2018 contract with Lassus Brothers INC, estimated not to exceed \$150,000. for 57,000 Gallons. Per gallon price is of OPIS pricing which changes daily. The price of the Diesel fuel today would have been \$\_\_\_\_\_ per gallon. The price of this commodity changes on a daily basis.

This is a unique opportunity to obtain diesel fuel for 2018 from twenty eight local stations throughout the area. This is used by the Public safety/Fire Department and Street Department throughout the year so they do not have to drive back to the Lafayette street complex to refuel having to go out of service. Along with City Utilities departments in emergency such as a flood to keep the large pumps running.

City Fleet Management is able to down load transactions from Lassus daily and import into the City Fleet management software program just like if they had fueled at the City complex.

Lassus Brothers is registered as buy Indiana and local Fort Wayne Company
