AN ORDINANCE approving 2018 RESURFACING PACKAGE NORTHEAST - RESOLUTION #0219A - \$1,088,555.00 between WAYNE ASPHALT and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the 2018 RESURFACING PACKAGE NORTHEAST - RESOLUTION #0219A - \$1,088,555.00 by and between WAYNE ASPHALT and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for street resurfacing in the northeast quadrant of the city. The scope may include milling into the asphalt surface and intermediate layers, adjusting castings and adding pavement markings;

involving a total cost of ONE MILLION EIGHTY-EIGHT THOUSAND FIVE HUNDRED FIFTY-FIVE AND 00/100 DOLLARS - (\$1,088,555.00). A copy of said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.
