All City Council Members,

The Fort Wayne Police Department Hazardous Devices Unit is the team that responds to the Suspicious Package/IED calls for service in the City of Fort Wayne. They also respond to similar calls for service in Allen County and the 11 Counties in Northeast Indiana. The FWPD HDU has also been tasked with providing protective sweeps and operational support for large events in Fort Wayne as the threat of IED's being used at such events has increased the last several years. Some of these events include the Fort for Fitness Run, Three Rivers Festival, and other events sponsored by the City of Fort Wayne in the downtown district. The Fort Wayne Police Department is requesting to purchase the SmartRay Vision to assist in providing support for these events and also enhance capabilities for Suspicious Package/IED response

The first step after responding to a suspicious package call is to diagnose if it is a threat or not. This requires the Bomb Tech to use X Ray Technology to look inside prior to moving, opening, or rendering safe the package. The current systems that the FWPD HDU utilizes is approximately 12 years old and employs old Imaging plate technology that is not easily transported to the scene without causing a disruption to the festivities or scene where the package is located. The new system is more portable and easily transported by the Bomb Tech.

The new Smart Ray Vision system allows the Tech to lower the amount of XRay energy being introduced into the suspect package from the xray source. This decreases the likelihood of the IED detonating prematurely which could potentially cause injury to Public Safety officials, the Public, and the Bomb Tech who may gather at the scene or be responding to provide operational support.

Bomb Squads/Hazardous Devices Units throughout the country buy a majority of their equipment directly from the manufacturer. This is because of the specialized nature of IED response and the limited number of manufacturers for some types of equipment that the HDU utilizes. Before equipment is endorsed for use by the Military and DOJ, it has to be tested by the Department of Defense at Sandia National Labs and Department of Justice at the Hazardous Devices School and Counter IED Unit in Quantico, VA. The SmartRay Vision system has undergone these tests and is currently used by US Military EOD Units and Public Safety Squads throughout the United States.
