9 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

10 **SECTION 1.** That the CONSTRUCTION CONTRACT - 0232S -
11 DECATUR ROAD SIDEWALK CONNECTION by and between KEY CONCRETE
12 and the City of Fort Wayne, Indiana, in connection with the Board of Public Works,
13 is hereby ratified, and affirmed and approved in all respects, respectfully for:

14 All labor, insurance, material, equipment, tools, power,
15 transportation, miscellaneous equipment, etc., necessary for
16 construction of new sidewalk on the west side of Decatur Road
17 from Gable Road to E. Paulding Road. This project also
18 includes re-profiling and extending the existing ditch line,
19 improving storm infrastructure by adding structures to the ditch
20 line and culvert pipes under new drive approaches;

21 involving a total cost of THREE HUNDRED SIXTY-SEVEN THOUSAND SIX
22 HUNDRED FIVE AND 00/100 DOLLARS - (\$367,605.00). A copy of said Contract
