Date: December 6, 2018

The Fort Wayne Parks and Recreation Department is requesting approval on behalf of the Board of Park Commissioners for a contract with Hamilton Hunter Builders Inc. for the Promenade Park Site Amenities Project. Base Bid for this project consists of the provision of the park tables, chairs, benches, bike racks, games, swings, and trash receptacles for the park. Three alternates were requested. Alternate bid 2A is for the provision of three gas fireplaces, Alternate 2B is for replacing two trash receptacles on the sidewalk to match the others in the park, and Alternate 2C is a credit for removing the tables, chairs, bike racks, picnic tables, benches, and trash receptacles in lieu of the owner purchasing them directly through the manufacturer.

Bids were received on December 4, 2018. 5 companies had picked up plans for the project and one company, Hamilton Hunter Builders, Inc submitted a bid. After review of all of the bids by project engineers the Parks Department would like to accept the base bid and all of the alternates for a total cost of \$170,823.00.
