Members of City Council:

This ordinance is to authorize the purchase of an integrated data protection appliance (IDPA) from Dell EMC, Inc. as part of the City, County, and City Utilities disaster recovery plan. The cost for this device is \$494,172.00. State QPA: State of Indiana Participating State contract number 0000000000000000000015711; and the EMC NASPO ValuePoint Master Price Agreement number MNWNC-109.

The IDPA will be a core element of our Disaster Recovery Plan, which encompasses all City, County, and City Utilities departments. A disaster recovery plan (DRP) is a documented process or set of procedures to execute an organization's disaster recovery processes and recover and protect a business IT infrastructure in the event of a disaster.

The cost for this device is divided between Fort Wayne Civil City (33.3%), Allen County (33.3%), and Fort Wayne City Utilities (33.3%). The share was determined by the approximate ratio of data managed by the device.

Dell EMC Integrated Data Protection Appliance (IDPA) is a pre-integrated, turnkey solution that is simple to deploy and scale, provides comprehensive protection for a diverse application ecosystem, and comes with native cloud tiering for long-term retention. Our decision to purchase this device is based on a recent assessment of our disaster recovery and business continuity plan.
