18 permits held for Riverfront Phase I;


19 involving a total cost of **FOUR HUNDRED TWENTY-ONE THOUSAND SIX**

The Fort Wayne Parks and Recreation Department is requesting approval for the purchase of credits associated with the Indiana Department of Natural Resource In-Lieu Fee Program.

The DNR's In-Lieu Program is a fee-based program that is carried out through the fees collected from credit sales to applicants who elect to use the ILF program to fulfill their compensatory mitigation requirements. It is our intent to purchase these credits in an effort to fulfill the mitigation requirements of permits held for Riverfront Phase I. Information about the ILF program can be found at <https://www.in.gov/dnr/heritage/8340.htm>.

Requirements of permits associated with Riverfront Phase I include mitigation of sensitive landscapes (i.e. wetlands) that were impacted in the project area. Construction, maintenance and monitoring of these projects, as required by permitting agencies, are costly and time-prohibitive, while also carrying the challenge of strict success criteria.

A cost comparison identifying both the cost of ILF credits and the estimated costs associated with construction, maintenance and monitoring of mitigation projects is identified on the attached spreadsheet. We recognize the monetary savings associated with the in-lieu program, and request that we may purchase credits to satisfy the mitigation requirements set forth by the permitting agencies for the cost of \$421,680.00. A budget of \$500,000 for assumed mitigation costs was established during the planning stages of Riverfront Phase I.
