5 **WHEREAS**, the City of Fort Wayne passed Annexation Ordinance X-1-18
6 to annex an area of approximately 105 acres located north of the City boundary
7 known as the La Cabreah Annexation; and,

8 **WHEREAS**, the City of Fort Wayne as required by annexation statute IC
9 36-4-3-(8), will establish the La Cabreah Annexation Fund; and,

10 **WHEREAS**, this fund will be established for the purpose of accounting for
11 any excess municipal property taxes and expenditures of additional services for
12 the annexed area not provided in fiscal plan and,

13 **NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF**
14 **THE CITY OF FORT WAYNE, INDIANA:**

15 **SECTION 1.** The establishment of the La Cabreah Annexation Fund.

16 **SECTION 2.** That this Ordinance shall be in full force and effect from and
17 after its passage and any and all necessary approval by the Mayor.
