The city of Fort Wayne is continually improving the water and waste water utility to meet additional customer demands and regulatory compliance. In this increase, the quantity of process equipment and appurtenances is increasing as well to meet this demand. In order to effectively and efficiently maintain the assets and equipment, City Utilities has standardized critical equipment.

Automated equipment industrial controllers, specifically Programmable Logic Controllers (PLCs), have been standardized by the utility.
