

1 **BILL NO. S-20-03-01**

2 **SPECIAL ORDINANCE NO. S-43-20**

3 **AN ORDINANCE approving the financing of various vehicles**
4 **and equipment items by the City of Fort Wayne; authorizing**
5 **acceptance of a lessor; and approving other actions with**
6 **respect thereto.**

7 **WHEREAS**, the City of Fort Wayne needs to acquire various vehicles and
8 equipment items for use by several departments of the City of Fort Wayne for continued effective
9 operations; and

10 **WHEREAS**, various bids have been let for the acquisition of various vehicles and
11 equipment items and Common Council approval of the acquisition of said various vehicles and
12 equipment items has either been received or is pending; and

13 **WHEREAS**, this Common Council now deems it in the public interest to finance
14 said various vehicles and equipment items rather than outright purchase said items; and

15 **WHEREAS**, sufficient net revenues are available from the City to make lease
16 financing debt payments on a timely basis as required for the financing of various vehicles and
17 equipment items; and

18 **WHEREAS**, an informal request for quotes for lease financing in accordance
19 with IC 5-22-6-1 from lessors was made to acquire the various vehicles and equipment items and
20 to lease same to the City, pursuant to the terms and conditions contained in Exhibit "A"; and

21 **WHEREAS**, the proposed financing provides for fair and reasonable rental and
22 other equitable terms and conditions and, further, that the execution of said financing will permit
23 the use and acquisition of said various vehicles and equipment items within the present financial
24 capabilities of the City and therefore same is in the public interest.

25 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE**
26 **CITY OF FORT WAYNE, INDIANA:**

27 **SECTION 1.** The Common Council of the City of Fort Wayne hereby authorizes
28 the City to lease, as lessee, those various vehicles and equipment items listed on the attached
29 Exhibit "A", made a part hereof. It is understood that the exact lessor purchase costs for such
30 various vehicles and equipment items listed on the Exhibit "A" shall be determined in accordance
with bidding procedures of this City and accordingly subject to approval by this Common Council;

1 however, the gross cost for such purchases excluding financing costs shall not exceed Thirteen
2 Million One Hundred and Eight Thousand and no/100 Dollars (\$13,108,000).

3 **SECTION 2.** The Common Council of the City of Fort Wayne hereby authorizes
4 the City to enter into the lease financing upon the determination by the City Attorney.

5 **SECTION 3.** The City is hereby empowered and authorized to award lessor
6 rights to the most responsive and responsible quoter as it determines in its sole judgment and
7 based on its criteria.

8 **SECTION 4.** The Mayor, the City Controller and the City Deputy Controller are
9 empowered and authorized to execute, on behalf of the City, leases and other documents as
10 contemplated herein with lessor so selected.

11 **SECTION 5.** This ordinance shall be in full force and in effect from and after its
12 passage and approval by the Mayor.
