3 **AN ORDINANCE** approving the initial purchase of
4 a Dell Isilon Network Attached Storage devices at a
5 total cost of \$447,000 from Dell Financial Services
6 LLC and through Allen County, Indiana by the City
of Fort Wayne, Indiana,

7 **WHEREAS**, Allen County, City Utilities, and the City of Fort Wayne
8 jointly operate an internal computer network for the purposes of
9 running their respective organizations community;

10 **WHEREAS**, the data storage requirements for the organizations
11 continue to grow for purposes such as geographic information
12 systems, document retention, drone video, sewer video, and
13 body cam video;

14 **WHEREAS**, the existing data requires regular backup for business
15 continuity and mitigation of malware threats to data;

16 **WHEREAS**, Allen County, City Utilities, and the City of Fort Wayne
17 wish to provide for disaster recovery of our joint computing
18 resources;

19 **WHEREAS**, Allen County, City Utilities, and the City of Fort Wayne
20 have jointly agreed to share equally in the cost of adding data
21 storage, backing up our data, and establishing disaster
22 recovery by means of a remote location for data storage;

24 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
25 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

26 **SECTION 1.** That the purchase of Dell Isilon Network Attached
27 Storage devices for a cost to the City of \$298,000 is hereby approved in all

Subject: Data Storage, Backup, and Disaster Recovery Hardware

Members of City Council:

This ordinance is to authorize the purchase and installation of a Dell EMC Isilon H400 Hybrid NAS and a Dell EMC Isilon A200 Archive NAS.

This is a shared purchase between Allen County, City Utilities, and the City of Fort Wayne. The total cost is \$447,000 and it will be split equal between the three organizations. The City's obligation is \$298,000.

This system provides several benefits:

- Allow the organization to handle increased data storage requirements, such the requirements for video storage.
- Allows the organization to reduce the current costs of Azure cloud backups. We expect the total cost saving across all three organizations to exceed \$200,000 in 2021.
- Allows the organization to establish a remote disaster recovery site. The building holding the existing data center requires asbestos mitigation. This hardware is the first step in establishing a site to maintain operations if the existing site is unavailable.

The project is in the 2021 budget. Dell finance has offered us 0% financing. Since 0% financing is available the project will start as soon as City and County receive spending authorization, buy payments will not begin until 2021.

Effective data storage and backups are essential for daily operations. Increased use of video equipment in all departments are increasing our data requirements. Disaster recovery helps us prepare for events such as floods, tornados, or train derailments. These reasons make this purchase essential for good operation of the City and County.
