16 action necessary for the purchase of this system by and through Verizon Wireless.

17 **SECTION 3.** That this Ordinance shall be in full force and effect from
18 and after its passage and any and all necessary approval by the Mayor.

Subject: Annual fees for Broadband access for Public Safety vehicles

Members of City Council:

The reason for this purchase is to allow computers in Public Safety vehicles to communicate with 911 dispatch and other public safety vehicles.

This ordinance will authorize the annual purchase of Broadband access for Public Safety from Verizon Wireless for communication with the City's police vehicles. This year's cost of maintenance for telephone software is \$154,492. The Police department intends to have broadband access in 429 vehicles in 2020, but the actual number will vary as vehicles go in and out of service.

The effective cost per unit is \$30.01 per month and provides full speeds for up to 5gb of data per month.

The Indiana Office of Technology periodically enters into contracts to provide quantity purchase agreements for units of government in Indiana. The prices for this purchase are from Indiana QPA #09847, amendment 9. The Indiana QPA is based on Federal # GS-35F-0119P.

The prices in this contract were the same as prices in similar Indiana Office of Technology contracts with Sprint and AT&T. Due the substance cost in officer time and money of switching service providers, I recommend continued use of Verizon Wireless for Broadband access on the City's public safety vehicles.
