

3 **AN ORDINANCE releasing Access Originator**
4 **funds from the Cable TV Fund.**

5 WHEREAS, Fort Wayne City Code § 111.34(C)(1) establishes the City
6 Council as the approver for Cable Fund access dollars; and

7 WHEREAS, Special Ordinance S-19-20 directs the Cable Fund Access
8 Board to come before the City Council for disbursement of additional funds paid
9 from access originator fees to the higher education Access Originator; and
10 from access originator fees to the higher education Access Originator; and

11 WHEREAS, continued funding is required to maintain channel operation
12 by the higher education Access Originator, CTV Consortium, in 2021.


13 **NOW, THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL**
14 **OF THE CITY OF FORT WAYNE, INDIANA:**

15 SECTION 1. That this Ordinance authorizes the City of Fort Wayne,
16 during the calendar year of 2021, to release Cable Access Funds to the CTV
17 Consortium according to the process set forth in Fort Wayne City Code §
18 111.34(C)(2).

20 SECTION 2. As provided in Fort Wayne City Code § 111.34(C)(4), CTV
21 should communicate the following items in their web site and annual report:

- 22 1. A programming guide for access channel programming.
23 2. Annual Reporting Details
24 a. Budget
25 i. Income
26 ii. Expenditures
27 b. Outreach to other High Education institutions
28 c. Staff, both paid and unpaid
29 d. Programs aired, detailing hours, producers, and
30 associated institutions
e. Students Served, including checkout and associated institutions

1 SECTION 3. That this Ordinance shall be in full force and effect from and
2 after its passage and approval by the Mayor.

Special Ordinance S-19-20 established CTV Consortium as the cable TV Access Originator for higher education, as per Fort Wayne City Code §111.34. The Special Ordinance also required additional Council approval to release additional funds.

This ordinance will authorize, in the calendar year 2021 only, the payment of Cable Fund access dollars to CTV Consortium in same manner as the other access channel originators. The ordinance also includes measurable objectives for the access channel to achieve in 2021.
