

AN ORDINANCE approving the purchase and installation of one hundred Vertiv Uninterruptable Power Supplies for the City of Fort Wayne and Allen County for a total cost not to exceed of \$144,000 from and through KSM Consulting by the City of Fort Wayne, Indiana,

Whereas, the City of Fort Wayne, City Utilities, and Allen County jointly operate computer systems and networks to benefit of all City and County departments;

Whereas, uninterruptable power supplies ensure the operation of the edge network equipment during power failures;

Whereas, the existing uninterruptable power supplies have reached the end of their useful lives;

Whereas, the City of Fort Wayne, City Utilities, and Allen County wish to jointly contract and share the cost of purchasing hardware through KSM Consulting.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the purchase and installation of one hundred Vertiv Uninterruptable Power Supplies for the City's computing infrastructure from KSM Consulting for a total of cost to the City of \$144,000 is hereby approved in all respects. That said purchase will be used to ensure the proper operation of the networking infrastructure throughout the City.

SECTION 2. That the City is authorized and directed to take all action necessary for the purchase of these service by and through KSM Consulting.
