

AN ORDINANCE approving the purchase of email protection software for the City of Fort Wayne and Allen County for a total cost not to exceed of \$107,856 from and through KSM Consulting by the City of Fort Wayne, Indiana,

Whereas, the City of Fort Wayne, City Utilities, and Allen County jointly operate computer systems and networks to benefit of all City and County departments;

Whereas, upgrading our email protection software will automate threat monitoring and response, reduce phishing, backup mailboxes, block spam, block sensitive data exfiltration, and retain emails for FOIA requests;

Whereas, this software will increase the security of our enterprise email environment;

Whereas, the City of Fort Wayne, City Utilities, and Allen County wish to jointly contract and share the cost of purchasing software through KSM Consulting.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the purchase of email protection software for the City's computing infrastructure from KSM Consulting for a total cost to the City of \$107,856 is hereby approved in all respects. That said purchase will be used to ensure the proper operation of the networking infrastructure throughout the City.

SECTION 2. That the City is authorized and directed to take all action necessary for the purchase of these services by and through KSM Consulting.

Members of City Council:

This ordinance is to authorize the purchase email protection software for the joint City and County computing environment. The cost of this software is to the City is \$107,856. Allen County will also contribute \$71,904 toward their share of this contract. The total cost is \$179,760.

Summary of the software's functions:

- Data Backup – Restore Exchange, SharePoint, and OneDrive data
- Threat monitoring and response – Identify email anomalies, search and delete attack email throughout the enterprise, and block future attacks
- Provide phishing awareness training – This will replace an existing standalone product
- Block spam
- Data Loss Prevention - Block sensitive data exfiltration, like HIPAA data and social security number, from being emailed
- Archiving - Retain emails for FOIA requests

This enhancement of part of a larger security review we've undertaken in 2021 and is one of our focus area priorities.
