Date: June 15, 2021

The City of Fort Wayne Parks and Recreation Department (FWPRD), on behalf of the Board of Park Commissioners has requested proposals with fees from firms qualified to prepare Construction Documents and Specifications, including Construction Administration for Phase I of the Franke Park Master Plan. Proposals from seven (7) design firms were received on April 1, 2021. Phase I includes the following general components:

1. New entrance into Franke Park from Goshen Avenue
2. New multi-use rentable pavilion
3. Connection from new Goshen Avenue entry to the existing vehicular and pedestrian circulation system
4. Removal of all maintenance facilities impacted by proposed new construction

Proposals were evaluated by a committee consisting of various administrative members of the FWPRD. All proposals were evaluated and judged according to their merit and demonstration of each company's project understanding, ability to complete, experience, methodology, and proposed fee. The successful team chosen by the selection committee was the Design Collaborative team. Please see attached scoring sheet.

We are requesting approval for a contract with Design Collaborative at a total cost of **\$996,000.00**. The City Controller will be approaching City Council for an appropriation of funds for this project. This project has the full backing of our Mayor.
