7 **Whereas**, Microsoft Office 365 is a cloud based office productivity
8 service that improves our security profile over self-hosted productivity servers
9 serves;

10 **Whereas**, city email and office software is being migrated to Microsoft
11 Office 365;

12 **Whereas**, Microsoft Office 365 software is vital to the City of Fort
13 Wayne's day to day business;

14 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
15 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**


16 **SECTION 1.** That the purchase of Microsoft Office 365 licenses for

Subject: Microsoft Office 365 licenses

Members of City Council:

This ordinance is to authorize the maintenance cost of Microsoft Office 365 licenses. The cost of this software to the City is \$460,000.

The project for converting to Microsoft Office 365 started in 2020. The pandemic and our transition to a new IT service provider has slowed the migration. I expect the migration to be completed in 2022.

I anticipate two major benefits to the Office migration 365 migration. First, it reduces our attack surface on Internet. We should be much more secure in this configuration.

Second, Microsoft Office 365 updates the collaboration features over our previous version of Microsoft Office. Video conferences are now possible and multiple people can edit the same document simultaneously.

I recommend funding the license for Microsoft Office 365.
