9 **Whereas**, GASB develops and issues accounting standards through a
10 transparent and inclusive process intended to promote financial reporting that
11 provides useful information to taxpayers, public officials, investors, and others
12 who use financial reports;

13 **Whereas**, timely and accurate GASB reporting lowers the cost of
14 financial transactions required for the running of the City of Fort Wayne and
15 City Utilities, and provides accountability and financial disclosure;

16 **Whereas**, every year since 1990 the City of Fort Wayne has produced
17 a Annual Comprehensive Financial Report (ACFR) and received the
18 Certificate of Achievement for Excellence in Financial Reporting from the
19 Government Finance Officers Association of the United States and Canada.

20 **Whereas**, the City of Fort Wayne and City Utilities routinely use
21 Workiva financial reporting software to increase the speed and accuracy of
22 GASB reporting;

23 **Whereas**, the City of Fort Wayne and City Utilities wish to jointly
24 contract and share the cost of software through Workiva Inc.

25 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
26 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

27 **SECTION 1.** That the purchase of financial reporting software for the
28 City's annual ACFR reporting from Workiva Inc for a total of cost to the City of
29 \$104,377.32 is hereby approved in all respects.

30 **SECTION 2.** That the City is authorized and directed to take all
action necessary for the purchase of this software by and through Workiva Inc.
