<i>Identify need for project & describe project; attach supporting documents as necessary.</i>	<p>This contract is for the removal of 154 trees currently located within the right-of-way and along our City’s streets, specifically lists titled 22A, 22B, and 22D. Each year, certified arborist’s with advanced training in tree risk assessment visually inspect all of the nearly 50,000 street trees located within the right of way. This inspection results in several hundred trees being identified as presenting an unacceptable level of risk annually and subsequently, scheduled for removal. Typically, these tree removals are completed by in-house Parks Department forestry staff. Due to recent challenges attracting and retaining staff within the forestry division, this task must be outsourced.</p>
