4 AN ORDINANCE ESTABLISHING THE
5 RIVERFRONT PHASE II BOND FUND.

6 WHEREAS, in July 2022, Resolution R-22-06-07 was adopted by the
7 Common Council in which the transactions regarding the Public Improvements,
8 the Lease, as approved by the Redevelopment Commission and the
9 Redevelopment Authority, in regards to Riverfront Phase II, and the issuance of
10 the Bonds by the Redevelopment Authority for Riverfront Phase II were all
11 approved; and,

12 WHEREAS, the public purpose of the Bonds is to acquire the Public
13 Improvements, for the ultimate purpose of providing funding for the acquisition,
14 demolition, site preparation, construction, installation and equipping of
15 improvements in the vicinity of Promenade Park, consisting of at-grade trails,
16 elevated trails, a wetland boardwalk, new boat docks, gathering places and
17 related improvements; and,

18 WHEREAS, the proceeds of the Bonds will be used to (a) finance the
19 acquisition of the Public Improvements, (b) fund all or a portion of a debt service
20 reserve fund, and (c) pay certain financing and other expenses incidental
21 thereto, including all expenses incurred in connection with or on account of the
22 issuance of the Bonds; and,

23 WHEREAS, the 2022 Riverfront Phase II Bond Fund shall be established
24 for the purpose of holding, accounting for, administering and appropriating all
25 funds for this specific project.

26 NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL
27 OF THE CITY OF FORT WAYNE, INDIANA:

28 SECTION 1. The establishment of the 2022 Riverfront Phase II Bond
