4 **AN ORDINANCE ESTABLISHING THE FEDERAL**
5 **SEIZURE FUND**

6 **WHEREAS**, in 2022, the U.S. Department of Justice (DOJ) Office of the
7 Inspector General (OIG) completed an audit to assess whether equitably
8 shared revenue has been accounted for properly and used for allowable
9 purposes by the Fort Wayne Police Department; and,

10 **WHEREAS**, a recommendation from the DOJ was to establish an accounting
11 mechanism to produce a separate report from the financial system and
12 accurately allocate interest income earned on all DOJ equitable sharing
13 funds separately from all other agency grant dollars; and,

14 **WHEREAS**, the Fort Wayne Police Department responded that a separate fund
15 will be established to meet the DOJ recommendation; and,

16 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL**
17 **OF THE CITY OF FORT WAYNE, INDIANA:**

18 **SECTION 1.** The Federal Seizure Fund shall be established for the
19 purpose of holding, accounting for and administering the funds per DOJ
20 requirements.

21 **SECTION 2.** That this Ordinance shall be in full force and effect from and
22 after its passage and any and all necessary approval by the Mayor.






