
7 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF**

15 Involving an annual cost of EIGHTY-FOUR THOUSAND AND 00/100 DOLLARS  
16 – (\$84,000.00) – is hereby in all things ratified, confirmed and approved.

17 **SECTION 2.** That this Ordinance shall be in full force and effect from and  
18 after its passage and any and all necessary approval by the Mayor.


ADDENDUM TO AGREEMENT BETWEEN BOSE PUBLIC AFFAIRS GROUP  
AND THE CITY OF FORT WAYNE

SECTION 1. This Addendum modifies and supplements the Representation Agreement between Bose Public Affairs Group and the City of Fort Wayne, entered into on the 22<sup>nd</sup> day of December 2010. This addendum modifies the agreement date to be effective beginning January 1, 2023, and the Agreement shall continue in full force and effect through December 31, 2023.

SECTION 2. As compensation for the performance by BPAG of its obligations under this Agreement, Fort Wayne agrees to pay BPAG \$7,000 per month, totaling \$84,000.


SECTION 3. This Agreement constitutes the entire contract between the parties and no other promises or representations have been made. Any modifications to this Agreement must be made in writing.
