10 The Mayor; all members of the Common Council; and the City Clerk; and

11 WHEREAS, this Ordinance has been published in accordance with I.C. 5-3-1-2, et seq., with the  
12 first publication having been at least thirty (30) days before final passage by Common Council.

13 NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF  
14 FORT WAYNE, INDIANA:


15 SECTION 1. That the following salaries are hereby fixed for the year 2024 with respect to the
