15 **SECTION 1.** That the City's payment of their share of GIS costs to the  
16 Allen County Board of Commissioners for a total of \$250,000 is hereby approved in all  
17 respects.

18 **SECTION 2.** That the City is authorized and directed to take all action  
19 necessary for the transfer of these funds to the Allen County Board of Commissioners.

20 **SECTION 3.** That this Ordinance shall be in full force and effect from and  
21 after its passage and any and all necessary approval by the Mayor.

Subject: Geographic Information System cost

Members of City Council:

In 2009 the City of Fort Wayne and Allen County entered an interlocal agreement to use a common Geographic Information System and to share the costs equally. The interlocal covers these items:

- Software maintenance
- Hardware maintenance and replacement
- Aerial Imaging

Hardware costs are expected to be insignificant in 2024.

Software costs are typical, about \$500,000 in 2024. The current three-year software contract will end after 2024.

Aerial imaging costs will be \$82,223 in 2024. Imaging products will be orthophotography and building outlines. Allen County has sufficient funds from previous years to cover this cost.
