The City of Fort Wayne Fleet Department is seeking the approval to increase its purchase order with Bob Thomas Ford by \$40,000. This increase is to cover the following:

1. Increased parts and labor charges due to the increase/severity of accidents and incidents with City assets.
2. Increased cost of parts due to inflation.
3. This includes at fault and not at fault repairs with City assets.
4. Fleet is not asking for additional funding; we are only requesting the P.O. amount be increased. We have the additional money for this increase already in our budget for this year.

As Fleet Management moves forward, we expect to continue to internalize more repairs to reduce outside labor costs. Our goal is to continue to internalize as many repairs as possible over the next 12 months which will better utilize our staff and increase turnaround times for the departments which will allow us all to better serve the people of Fort Wayne.
