9 Ordinance fixing the salaries of elected officials in accordance with I.C. 36-4-7-2; and

10 WHEREAS, this Ordinance applies to all elected officials of the City of Fort Wayne, Indiana,  
11 to wit: The Mayor; all members of the Common Council; and the City Clerk; and

12 WHEREAS, this Ordinance has been published in accordance with I.C. 5-3-1-2, et seq., with  
13 the first publication having been at least thirty (30) days before final passage by Common  
14 Council.

15 NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE  
16 CITY OF FORT WAYNE, INDIANA:

17 SECTION 1. That the following salaries are hereby fixed for the year 2025 with  
18 respect to the City's elected Officials.

21	CITY CLERK	\$101,624.00

22 SECTION 2. That this Ordinance shall be in full force and effect from and after its  
23 passage and any and all necessary approval by the Mayor.
