7 **Whereas**, the City of Fort Wayne, City Utilities, and Allen County share
8 a common computing and networking infrastructure;

9 **Whereas**, security firewalls and VPNs are vital to the safe and secure
10 operation of computers and networks within our organizations;

11 **Whereas**, the City of Fort Wayne, City Utilities, and Allen County wish
12 to jointly contract and share the cost of service agreements through
13 ITSavvy LLC.

14 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
15 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

16 **SECTION 1.** That the purchase of service agreements for security
17 firewall and VPN software from ITSavvy LLC for a total cost to the City of
18 \$108,936.62 is hereby approved in all respects.

19 **SECTION 2.** That the City is authorized and directed to take all
20 action necessary for this purchase by and through ITSavvy LLC.

21 **SECTION 3.** That this Ordinance shall be in full force and effect from
22 and after its passage and any and all necessary approval by the Mayor.

Subject: Firewall and VPN service agreement

Members of City Council:

This ordinance is to authorize the purchase service agreements for our security firewall and VPN software. The total cost of this software is \$108,936.62. Allen County and Civil City each agree to pay 40% of the cost and City Utilities agrees to pay 20% of the cost.

The cost decreased 26% due by reducing the scope and merging several smaller contracts into one contract.

The vendor is ITSavvy LLC, a software reseller recommended by the Indiana Office of Technology. The service agreement for software embedded in our firewall and VPN hardware.

The firewall is the first line of defense between the Internet and our internal systems. The VPN securely extends the reach of our network to remote locations, such as Fire Stations, firetrucks, squad cars, and employees working remotely.

Both firewall and the VPN are integral to the safe and efficient operation of government. I firmly recommend approving this ordinance.


