8 **Whereas**, fiber optic data connectivity enables fast, secure data  
9 connections to buildings miles away;

10 **Whereas**, fire stations, police outposts, remote government buildings  
11 and remote data centers require fiber connections for interfacing with  
12 City networks and computer systems;

13 **Whereas**, Zayo provides fiber optic service throughout Indiana;

14 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**  
15 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

16 **SECTION 1.** That the purchase of fiber optic service for various  
17 City's buildings Zayo Group, LLC for a total cost to the City of \$195,000 is hereby  
18 approved in all respects.

19 **SECTION 2.** That the City is authorized and directed to take all  
20 action necessary for the purchase of this software by and through Zayo Group,  
21 LLC.

22 **SECTION 3.** That this Ordinance shall be in full force and effect from  
23 and after its passage and any and all necessary approval by the Mayor.
