This correspondence is for consideration of the purchase of Cellebrite Inseyets Software Licensing.

Cellebrite Inc. is a forensic utility provider and leader in mobile device forensics that supports over 60,000 users around the globe. The Fort Wayne Police Department has been utilizing Cellebrite products and services in the Digital Forensics Laboratory since 2010.

As part of the mission of FWPD, the Digital Forensics Unit retrieves digitally stored data from electronic devices involved in criminal investigations. The FWPD digital forensic examiners now face several challenges, including access to locked and encrypted devices, the wide variety of data sources including mobile devices, computers, cloud storage, etc, and the ever-growing volume size of the data collected from these devices.

To address these challenges, Cellebrite Inseyets is equipped with unique capabilities that are exclusive to Cellebrite and not available from any other company.
