Zoning Map No. O-06 (Sec. 1 of Wayne Township)**


BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE,
INDIANA:

SECTION 1. That the area described as follows is hereby designated an R3
(Multiple Family Residential) District under the terms of Chapter 157 Title XV of the Code of
the City of Fort Wayne, Indiana:

Lots numbered 47 through 49 inclusive in the College Addition to the City of Fort Wayne as
recorded in Deed Book 35, page 163 in the Office of the Recorder of Allen County, Indiana,
containing 0.52 acres, more or less.

and the symbols of the City of Fort Wayne Zoning Map No. O-06 (Sec. 1 of Wayne
Township), as established by Section 157.082 of Title XV of the Code of the City of Fort
Wayne, Indiana are hereby changed accordingly.
