3 **A NON-BINDING RESOLUTION requesting further attention and definition to**
4 **certain meanings in the Fort Wayne Zoning Code**

6 **WHEREAS**, there are instances where gaming and betting is legal in Indiana; and

7 **WHEREAS**, the C3 (General Commercial) zoning classification does allow as a specific
8 permitted use “betting or other gaming facility”; and

9 **WHEREAS**, “betting and other gaming facility” does not provide clear guidance on a definition
10 and as more facilities attempt to locate in the community, further explanation is needed.

11 **NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY**
12 **OF FORT WAYNE, INDIANA,**

13 **SECTION 1.** By passage of this resolution, the Fort Wayne City Council requests that the
14 Department of Planning Services initiate the process to further define what is meant by “betting
15 and other gaming facility” and determine if this use is correct in C3 (General Commercial).
